

Subject: Sanction of Rs.2,25,000/- for organizing a Mational Seminar/Conference on "Understanding Women: The Gender Essed Role Crises"

Dear Sir/Madam,

Sanction of the Council is hereby accorded for the payment of Rm.2,25,000/(Rupees two lakh twenty five thousand only) to meet the expenditure on the
above mentioned seminar/conference organised by Dr. Ranjana Sinha during 1415 July, 2018.

The sanctioned amount will be released in two installments as follows:

Piret installment: Rs. 2,02,5007-Second installment: Rs. 22,500/-

The First installment of Rs.2,02,500/- will be released on receipt of the grant-in-aid bill(copy enclosed) duly signed and stamped by the competent authority of the Institution/College/University.

The second installment of Rs.22,500/- will be released only after receiving the proceedings of the seminar in a publishable form along with the following documents that may please be submitted at the earliest after holding the Beminar.

- I. The complete proceedings (hard bound copy) of the seminar/conference that should necessarily constitute of the following:
 - . List of the actual participants of the seminar.
 - . The exect titles & presenters of each of the session.
 - . Proceedings of Seminar with full papers.
 - . A note on the contribution of the seminar to the existing body of research.
- II. The sudited head-wise statement of accounts and utilization certificate in GFR (Form 12A-copy enclosed) for the entire expanditure incurred from the sanctioned amount. Both these needs to be duly certified by the Chartered Accountant/Finance Officer (in case of Cantral University), Convener and the Head of the concerned institution/college/university.

The above documents are mandatory requirement to settle the account and enable us to release the final installment.

The other conditions are:

- The financial assistance should be utilized for the purpose for which it has been sanctioned.
- A part of the assistance is to be utilized for publication of the proceedings of the seminar/conference.
- The amount sanctioned herein is to be utilized on the proposed seminar/conference.
- Any amount of the assistance remaining unspent during the current
 financial year shall be refunded to the ICSSR immediately after
 completion of the seminar/conference. If the organization do not
 refund the amount in time, it will be required to refund the
 amount of the grant with interest thereon 9 10% per annum from
 the date of the issue of cheque.

As per the directives from the Government of India, all the payments are to be made by s-payments only. Kindly furnish the following information along with a cancelled cheque or copy of the first page of the Bank passbook duly verified by the administrative head of the Institution & also duly verified by the Bankers for RTGS/NEFT payments:
