Sub: Draft Statutes under Section 18(11) and 18(16) of the
Bihar State Universities Act, 1976 regarding formation
of Senate.

Sir,

I am directed to invite a reference to the subject cited above and to say that the Hon'ble Chancellor on recommendation of the Bihar Inter University Board, Patna has been pleased to approve the following amendments to the Statutes assented to earlier by the Hon'ble Chancellor relating ^{to} election/nomination of the representative members to the Senate/Syndicate under Section 18(11) & 18(16) and 22(i)(b) and 22(1)(i) of the Bihar State Universities Act, 1976 for implementation in your University.

Statutes U/s 18(11) of the Bihar State Universities Act, 1976

That the existing Statutes contained in Article 1 of Chapter III of the Statutes be replaced by the following :

"1. Subject to the provisions of the Act, five duly appointed Professors/Readers of the Colleges admitted to the privilege of the University (i.e. of admitted colleges) who are not Deans shall be nominated by the Chancellor to the Senate of the University for a period of three years, by rotation according to their respective seniority in the Faculty concerned, in the following manner :

Provided that if no duly appointed Professor/Readers are available in any of the group of Faculties, the Seat/Seats shall remain vacant."

Amendment to the Statutes relating to formation of Senate under the Provisions of section 18(16) of the Bihar State Universities Act, 1976 as amended up-to-date.

That the existing Statutes contained in Article 2 of Chapter III of the Statutes, be replaced by the following :

"2. Subject to the provisions of the Act, 15 teachers other than Deans, Principals and Heads of University Department, who possess at least 5 years teaching experience as a duly appointed teachers, shall be elected by the teaching staff of the University department and colleges in accordance with the system of proportional representation by means of single transferable vote, from the electoral Colleges A, B and C respectively in the manner prescribed below :

Electoral College - A: 3 members (One-SC, One-ST & One Gen.) to be elected to the Senate.

All duly appointed teachers of the University Departments of the faculties of Arts, Science and Commerce shall form the electoral College in this constituency for the purpose of election of 3 members to the Senate.

Electoral College-B: 9 members (One-SC, One-ST, 2-OBC & 5-Gen.) to be elected to the Senate.

All duly appointed teachers of constituent colleges of the University shall form the Electoral College in this constituency for the purpose of election of 9 members to the Senate.

Electoral College-C: 3 members (One-OBC & 2 Gen.) to be elected to the Senate.

All duly appointed teachers of the Colleges admitted to the privilege of the University shall form the Electoral College in this constituency for the purpose of election of 3 members to the Senate.

Provided that if no qualified candidates are available against reserved quotas for SC/ST & OBC community, the Seat/Seats shall remain vacant.

Provided further that teachers belonging to the reserved categories may also contest for general seats.

Statutes U/S 22(1)(h) of the Bihar State Universities Act, 1976

That the existing provisions contained in Article 2 of Chapter IV of the Statutes dealing with formation of Syndicate beginning with the words, "Two Readers, College Professors" and ending with the words, "of Chapter III of the Statutes," be replaced by the following:

"Two from amongst Professors/Readers of the University other than the University Heads of the Departments and two such lecturers as have a minimum of five years of teaching experience, to be elected by the teacher-members of the Senate by single transferable vote in accordance with the system of proportionate representation as indicated below, one of whom shall be from amongst Professors/Readers belonging to the category of OBC and one from amongst the Lecturers belonging either to the category of SC or ST. In case no qualified teacher of the reserved category mentioned above, is available, the seat shall remain vacant."

Statutes U/S 22(1)(i) of the Bihar State Universities Act, 1976

The existing provision contained in Article 4 of Chapter IV of the Statutes dealing with formation of Syndicate, beginning with the words, "Three members" and ending with the words, "indicated below," be replaced by the following:

"Five members of the Senate other than teachers, students and non-teaching employees of the University and the colleges under it, shall be elected to the Syndicate by the Non-teacher Members of the Senate by single transferable vote in accordance with the systems of proportionate representation in the manner indicated below, provided that one out of the aforesaid five members shall be from the Schedule Caste or Schedule Tribe community and one from the OBC category."
